# AFHA National Heritage Area Bill Introduced!

After years of hard work, AFHA accomplished a huge step forward this week!

Sen. Jay Rockefeller, with co-sponsors Sen. Joe Manchin of West Virginia, and Sen. Ben Cardin and Sen. Barbara Mikulski of Maryland, introduced a Senate bill this week to designate the Appalachian Forest Heritage Area as a National Heritage Area. Senate Bill 1641, "West Virginia National Heritage Area Act of 2013â€□ also extends the existing NHAs in West Virginia, the National Coal Heritage Area and Wheeling National Heritage Area, until 2017.

"We are thrilled that our Senators are sponsoring this bill to bring national recognition to the forest heritage of West Virginia and Maryland,â€□

significant, and would authorize National Park Service technical assistance and funding. AFHA completed a Feasibility Study several years ago, which was reviewed and approved by the National Park Service as meeting the criteria for a National Heritage Area. Over 120 communities and


organizations have provided support letters for this designation.

"Our accomplishments include wide-ranging partnerships, conservation improvements, heritage tourism development, a vibrant AmeriCorps program, and the new Appalachian Forest Discovery Center opening soon in Elkins,â€□ said Baxter. "Our region is rich in natural resources, cultural heritage, and scenic beauty, but often lacking in economic opportunity. National Heritage Area designation will bring national recognition and helpful tools and support to help utilize our forest assets to benefit and improve our rural communities.â€□


