- Guest Speaker
 - Eric Thompson Access on the GO all volunteer organization that promotes accessibility for livability and business profitability
 - Free Accessibility Resources
 - Existing barriers for travelers with disabilities are the same as for other travelers. What do you need to attract any guest? They need to know the place exists and that it has what they are looking for (supporting documentation with enough info). Pictures showing ADA accommodations are very helpful, as existing descriptions may be inaccurate. Go through ADA self-assessment checklist (see resource list).

- People with disabilities make up one of the largest markets. Good accommodations will help overall business (word of mouth). Tax credits are available for tax liable organizations (can sometimes be managed by non-profit). ADA act is an opportunity rather than obligation. Pies & Pints good example of expansion. - There is a lack of existing inventory of existing infrastructure. We should combine local guides for a comprehensive regional inventory. Encourage CVBs to make accessibility themed guides. Make your inventory highly visible/easy to find on your webpage (like Canaan Valley Resort or WV Tourism).
- Recommended process: get buy-in from businesses by sharing the value of accessibility, do the ADA self-check list, create a transition plan, and make your inventory.
- Eric is trying to start a training program for how to do the assessments, where to find the funding, etc. There are gaps in resources for non-profits/governments/orgs without tax liability. Grants will often prioritize accessibility projects.
- Michele Moure-Reeves- Are there adaptive non-motorized flat water crafts? Creating Abilities sells parts to outfit canoes/kayaks. Info about public access sites in <u>Free Resource link</u> (River Management Society). There is also a recreational checklist in larger ADA checklist.
